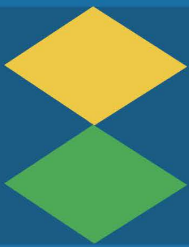
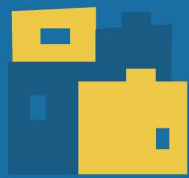

TASK FORCE 1

COMBATING INEQUALITIES, POVERTY, HUNGER, AND PROMOTING MENTAL HEALTH

1. CURRENT SCENARIO

The commitment to combating inequalities is a relatively recent milestone, gaining global recognition in 2015 as the 10th Sustainable Development Goal (SDG) of the United Nations. Addressing inequalities, poverty, and hunger in favelas and peripheral communities poses a complex challenge, compounded by regional disparities and the intergenerational cycle of poverty, particularly affecting families led by Black women. Hunger, affecting approximately 733 million people worldwide in 2023, is a direct consequence of poverty (FAO, IFAD, UNICEF, WFP, and WHO, 2024).

The lack of basic infrastructure, such as sanitation, adequate housing, and potable water, contributes to social vulnerability in favelas. Inequalities are exacerbated by intersections of race, class, and gender, with women and Black people most affected by poverty and lack of opportunities. Entrepreneurship and education in favelas face significant challenges, with most businesses operating informally and limited access to quality education.

Finally, mental health suffers due to police violence and public insecurity in favelas, where vulnerable populations such as women and the LGBTQIAP+ community, are disproportionately affected. Ensuring social inclusion for all is a globally shared aspiration. This is why the 10th SDG aims to “reduce inequalities within and among countries.”



2. RECOMMENDATIONS TO THE G20

1. **Creation of the Favelas and Peripheries Fund:** Prioritize investment in projects and initiatives aimed at improving the quality of life for residents of favelas and peripheral communities.
2. **Public Security Policy Reform:** Implement security policies that promote well-being and human rights, focusing on prevention and conflict resolution while ensuring equal treatment for all citizens.
3. **Credit for Local Entrepreneurs:** Expand specific lines of credit and training programs to support entrepreneurs in favelas, fostering local economic development.
4. **Inclusive and Quality Education:** Invest in educational infrastructure, school retention, and inclusive pedagogical methodologies and practices to develop quality education for all, valuing teachers and community participation.
5. **Basic Infrastructure:** Expand access to public transportation, health centers, sports facilities, and cultural centers in favelas, promoting social and economic inclusion.
6. **Right to Housing:** Implement housing policies to combat gentrification and ensure access to dignified housing for all favela residents.
7. **Sports Promotion:** Invest in local initiatives that promote sports as a means of social inclusion and improved quality of life.
8. **Access to Potable Water and Basic Sanitation:** Invest to ensure that all households have access to potable water and adequate sanitation, reducing health risks.
9. **Mental Health Policies:** Develop and implement public mental health policies accessible to all, focusing on community needs, decentralizing services, investing in professionals, and integrating with other policies.
10. **Combating Gender and LGBTQIAP+ Violence:** Create protection and support programs for women and LGBTQIAP+ individuals, combating violence and promoting equal rights.
11. **Strengthening Community Leadership:** Support, train, and mentor community leaders to defend the rights and interests of their communities effectively.
12. **Sustainable Development:** Promote sustainable development practices that include environmental preservation and climate adaptation.

- 13. Technology and Connectivity:** Invest in technological infrastructure to ensure equitable access to the internet and digital tools, promoting digital education and economy.
- 14. Food Security:** Implement policies to fight hunger, democratize access to healthy food, eliminate food deserts, and promote sustainable and family farming.
- 15. Social Participation and Advocacy:** Create mechanisms for social participation that allow communities to influence, impact, and shape public policies, ensuring the safeguarding of their rights.

TASK FORCE 2

COMBATING THE CLIMATE CRISIS AND PROMOTING A JUST ENERGY TRANSITION

1. CURRENT SCENARIO

Low-income neighborhoods and favelas are disproportionately impacted by the climate crisis, facing its harshest effects due to inadequate infrastructure and lack of urban planning. Transforming these areas into 'Green Favelas' and advancing an equitable energy transition are essential steps toward achieving sustainability and social justice. Yet, the escalating greenhouse gas emissions from deforestation and fossil fuel combustion intensify these challenges, underscoring the urgent need for inclusive public policies that prioritize and protect these vulnerable communities.

Climate justice aims to ensure that those most affected, especially Black and Indigenous communities, have access to a safe environment and benefit from targeted adaptation and mitigation policies that address the severe impacts of environmental racism. Including these areas in climate crisis strategies, with an emphasis on the active participation of Black women and youth, is crucial to the success of these initiatives.

2. RECOMMENDATIONS TO THE G20

- 1. Climate Financing:** Increase funding for specific climate actions in low-income neighborhoods and favelas, ensuring resources reach these communities.
- 2. Investment in Resilient Infrastructure:** Prioritize the construction of resilient infrastructure in favelas to mitigate the impacts of extreme weather events like floods and landslides, preventing community displacement.
- 3. Creation of a Reconstruction Fund for Favelas and Low-Income Areas:** This fund should be used to rebuild infrastructure, provide emergency assistance, support economic and social recovery in affected areas, and invest in projects and initiatives to mitigate climate impacts.
- 4. Implementation of Green Roofs and Vertical Gardens:** Promote the installation of green roofs and vertical gardens to reduce urban heat islands and improve air quality.
- 5. Sustainable Drainage Systems:** Develop and implement sustainable drainage systems to prevent flooding and improve stormwater management.
- 6. Circular Economy:** Encourage circular economy practices in favelas, promoting the reuse and recycling of materials to reduce waste and create job opportunities.
- 7. Urban Agriculture and Community Gardens:** Support community gardens and urban agriculture projects to enhance food security and promote environmental education.
- 8. Community Participation:** Ensure the active participation of local communities in the formulation and implementation of climate policies, valuing traditional knowledge and local practices.
- 9. Renewable Energy:** Promote the installation of renewable energy systems, such as solar panels, in favelas to reduce fossil fuel dependence and lower greenhouse gas emissions.
- 10. Monitoring and Transparency:** Establish robust monitoring and transparency mechanisms to ensure climate commitments are met and resources are used effectively.
- 11. Protection of Natural Ecosystems:** Implement measures to protect and restore natural ecosystems near favelas, contributing to climate resilience.



- 12. Technological Innovation:** Invest in research and development of clean and sustainable technologies, promoting technology transfer to low-income communities.
- 13. Inclusive Public Policies:** Develop and implement public policies that recognize the specificities of favelas and low-income areas, ensuring these communities are included in climate mitigation and adaptation strategies.
- 14. Women's Empowerment:** Recognize and value the role of women in natural resource management and community resilience, promoting their active participation in all stages of sustainability projects.



TASK FORCE 3

ACCESS TO POTABLE WATER, BASIC SANITATION, AND PERSONAL HYGIENE

1. CURRENT SCENARIO

Access to potable water, basic sanitation, and personal hygiene in favelas is a critical challenge that deeply impacts quality of life. Precarious infrastructure and government neglect leave entire communities facing issues such as a scarcity of potable water and a lack of adequate sanitation. In places like Complexo do Inhaúma, Rio de Janeiro, Brazil, families face weeks without water, seriously compromising hygiene, public health, education, the economy, and housing. With around 2.2 billion people globally lacking access to quality water and 3.6 billion without safe sanitation, urgent measures are required to address this enormous challenge (UNESCO, 2024).

Beyond structural issues, the situation is made worse by a lack of effective dialogue with authorities and by environmental racism, which negatively impacts low-income communities – largely Black and marginalized – disproportionately. Unfair water billing without addressing supply issues frustrates residents, highlighting the inequality in resource management. The accumulation of solid waste, inadequate drainage, and increased flooding further exacerbate basic sanitation challenges, worsening living conditions in these areas.

To ensure that global communities with similar characteristics to Complexo do Inhaúma, regardless of their location or socioeconomic status, have access to potable water, basic sanitation, and a clean environment, it is essential to make appropriate investments, develop well-planned public policies, and implement effective measures. Only through these efforts can we promote social and environmental justice in favelas and peripheral areas.



2. RECOMMENDATIONS TO THE G20

1. **Sustainable Financing:** Ensure adequate and sustainable financing for water and sanitation infrastructure projects, including the allocation of specific funds for vulnerable areas. We propose creating a dedicated fund, managed transparently, to ensure continuity of resources, prioritizing vulnerable communities.
2. **Investment in Infrastructure:** Invest in modernizing and maintaining water supply and sewage systems in favelas, replacing old pipelines and implementing advanced technologies. Establish partnerships to optimize resources and promote the rapid and effective implementation of technological and infrastructure improvements.
3. **Recognition of Human Rights:** Water must be recognized as a fundamental and universal human right. Embedding this principle in public policies and prioritizing legally guaranteed access to water and basic sanitation will drive both human and economic development in communities.
4. **Universal Access:** Ensure that all people, regardless of financial ability, have access to a minimum amount of water essential for survival. Develop subsidies and social tariffs that provide low-income populations with affordable and continuous access to essential water services.
5. **Review of Target Contracts for Favela and Peripheral Areas:** Review and update concession contracts to incorporate specific, measurable targets directed toward favela areas, ensuring that investments and infrastructure improvements are implemented transparently. Regular monitoring and audits are essential to ensure full compliance with these targets. Adopt a performance evaluation system with clear indicators to track progress and hold concessionaires accountable if they fail to meet set targets.
6. **Coverage Expansion:** Expand the coverage of potable water and basic sanitation services to reach all favelas and peripheral communities. Create ongoing investment programs prioritizing vulnerable regions, using detailed mapping to identify and prioritize underserved areas so that billing is clear and effective in case of failure.
7. **Fair Tariff Policies:** Implement billing policies that are fair and accessible, considering the payment capacity of favela and peripheral communities. Establish a system of progressive subsidies and social tariffs to ensure that no citizen is left without access to basic services due to financial limitations.
8. **Combating Environmental Racism:** Recognize and combat environmental racism, ensuring that all communities receive equal attention and resources. Implement public policies specifically aimed at equitable allocation of investments and ongoing oversight to prevent regional disparities.

- 9. Community Participation:** Involve affected communities in the lack of water and sanitation access in decision-making and solution implementation, ensuring their voices are heard. Establish community advisory committees and hold regular public consultations to incorporate local needs and perspectives into policy formulation.
- 10. Creation of Efficient Communication Channels:** Establish effective communication channels for residents to report issues and seek solutions quickly and efficiently. Develop digital and physical platforms that allow for immediate feedback, with a guaranteed response and quick resolution from authorities or responsible concessionaires.
- 11. Transparency and Accountability:** Ensure that authorities are transparent in their actions and responsible for resolving issues reported by communities. Publish regular progress reports and create accountability mechanisms to encourage the swift resolution of issues reported by the population.
- 12. Education and Awareness:** Promote environmental education and awareness campaigns on the importance of personal hygiene and basic sanitation for public health. Develop partnerships with organized civil society and local schools to train residents and community multipliers in sustainable and health practices.
- 13. Disease Prevention:** Implement programs to prevent diseases related to a lack of sanitation and hygiene, such as distributing hygiene kits and conducting community clean-up actions. Establish partnerships with public health organizations for ongoing monitoring and training in preventive practices.
- 14. Monitoring and Evaluation:** Develop and use performance indicators to monitor the progress of sanitation and water supply initiatives. Institute a metric and reporting system with set dates to assess the effectiveness of programs, based on data collected directly from communities.
- 15. Continuous Evaluation:** Conduct ongoing evaluations to identify areas for improvement and ensure that implemented actions are effectively improving living conditions in favelas. Implement an independent audit system to periodically assess results, adjusting strategies as necessary.
- 16. Technological Innovation:** Invest in research and development of new technologies to improve the efficiency and sustainability of water and sanitation systems in favelas and peripheral areas.
- 17. Disaster Resilience:** Develop disaster preparedness and response plans that include measures to ensure continuous access to potable water and basic sanitation during crises. Integrate sanitation infrastructure into municipal civil defense plans, ensuring rapid action protocols and the distribution of emergency supplies.



- 18. Accountability for Pipeline Breaks:** Implement clear accountability policies for concessionaires in the event of pipeline breaks. Establish fair compensation mechanisms for residents affected by ruptures. Ensure regular maintenance and inspection of pipelines. Require detailed contingency plans from concessionaires and create a compensation fund for impacted residents.
- 19. Including Community in the Debate:** Promote active community participation in discussions on sanitation and water management. Hold public consultations and hearings to listen to the needs and suggestions of residents. Include community representatives in planning and decision-making committees. Institutionalize the presence of community leaders on water and sanitation management boards, ensuring that their demands are an integral part of decision-making processes.

TASK FORCE 4

COMBATING NATURAL DISASTER RISKS

1. CURRENT SCENARIO

Aligned with the United Nations' 11th Sustainable Development Goal (SDG) — “making cities and communities more inclusive, safe, resilient, and sustainable” — addressing natural disaster risks in favelas and low-income neighborhoods is a critical challenge. Poverty forces many people to live in steep, hillside areas that are high-risk zones. The lack of adequate infrastructure and effective urban planning significantly contributes to the vulnerability of these areas. The unregulated expansion of favelas, often driven by real estate pressures, and the lack of public policies to create green spaces and protective zones further exacerbate these risks.

The lack of accountability for public managers is one critical issue, especially with regard to urban development, due to the absence of investment in infrastructure and urban planning policies that could improve safety in favelas. This failure perpetuates a legacy of social exclusion, forcing low-income, predominantly Black and Brown populations to live in vulnerable conditions without access to safe housing. The shortage of resources and effective policies remains a constant challenge to community safety. Furthermore, over 1 billion people worldwide live in favelas and low-income neighborhoods, and this number will rise in coming years if adequate urban planning is not implemented (UN-Habitat, 2023).

Therefore, mitigating natural disaster risks in favelas and low-income neighborhoods is essential. Promoting an integrated approach that considers both social needs and environmental factors should be prioritized to ensure policies that provide access to adequate housing and infrastructure for all.



2. RECOMMENDATIONS TO THE G20

1. **Investment in Urban Infrastructure:** Prioritize investment in urban infrastructure in favelas and low-income neighborhoods to democratize access to safe housing and dignified living conditions.
2. **Effective Urban Planning:** Implement urban planning policies that prevent disorderly expansion and ensure occupation of safe areas. Include favelas and low-income neighborhoods in city master plans, prioritizing participatory planning led by community members.
3. **Accountability for Public Managers:** Hold infrastructure service managers accountable, especially those in urban development, for the lack of investments and effective policies.
4. **Implementation of Drainage Systems:** Invest in efficient drainage systems to prevent floods and landslides.
5. **Creation of Green Spaces:** Develop green areas that can serve as natural barriers against disasters. Encourage initiatives by companies that seek to revitalize these spaces through structural, long-term solutions with tax incentives.
6. **Education and Awareness:** Promote education and awareness programs focused on natural disaster risks and preventive measures. Update school materials and provide incentives for public school teachers to disseminate environmental topics.
7. **International Support:** Encourage international cooperation for developing public policies and investments in infrastructure with clearly defined goals and deadlines.
8. **Monitoring and Early Warning:** Implement monitoring and early warning systems for natural disasters by investing in open-technology and innovation management models with civil society participation.
9. **Safe Resettlement:** Develop safe resettlement programs for residents in high-risk areas.
10. **Support for Disaster Victims:** create a relief fund to provide financial and psychological support to natural disaster victims through the emergency assistance, with minimized bureaucracy and rapid access during crises.

- 11. Environmental Sustainability:** Promote sustainable construction practices and environmental preservation, offering tax benefits for best practices in this area.
- 12. Transparency and Participation:** Increase transparency in public policies and community participation in decision-making through technology management and broad dissemination of social control methods.

TASK FORCE 5

TRANSFORMATION, DIGITAL, AND CULTURAL

1. CURRENT SCENARIO

Favelas and peripheral communities face profound challenges in areas such as education, culture, technology, and financing. Funding for local projects is a historical obstacle, worsened by the lack of transparency in fund allocations. Cultural transformation is essential for socio-environmental development. While digitalization is growing, it still faces barriers in favelas, with digital exclusion exacerbated by violence and lack of infrastructure. Technological initiatives, such as the Technology Station of João de Deus in São Luís do Maranhão, Brazil, and the Internet for All program, a Brazilian government initiative, are examples that need to be replicated and expanded to ensure safe and equitable access. Additionally, training people to access funding calls is essential for more projects to secure financing and transform their realities.

Digital and cultural inclusion, combined with financial and social education, is fundamental for the development of favelas and peripheral areas. Access to cultural and technological spaces positively impacts community mental health. Digital illiteracy, especially among the elderly, and the impact of fake news and harmful advertising on mobile devices are challenges that need to be addressed. Safe internet, accompanied by critical education on technology, is essential to guarantee true digital and cultural inclusion.

2. RECOMMENDATIONS FOR THE G20

1. **Establish a Global Fund for Digital Inclusion and Cultural Appreciation in Favelas:** Create a fund with contributions from G20 countries to finance digital inclusion and cultural appreciation projects in favelas, peripheral areas, and traditional communities, fostering a supportive environment for technological diversification and adding value to social innovations.
2. **Community Technology and Cultural Centers:** Establish community centers in each favela, providing access to computers, the internet, and training programs to empower residents and promote digital inclusion.
3. **“Internet for All” Program:** Expand access to high-speed internet across all favelas, utilizing innovative technologies such as satellite internet to overcome infrastructure and security barriers.
4. **Digital and Cultural Education Curriculum:** Develop a specific curriculum for schools in peripheral areas that integrates technology and local culture, to provide more inclusive and relevant education. Encourage technology education and combat fake news through research and discussion on the subject.
5. **Mentorship Program for Youth:** Create a mentorship program connecting youth from favelas with successful professionals in technology and culture to inspire and guide new generations.
6. **Quota System for Cultural and Technology Projects:** Implement quotas in public and private funding calls for projects led by favela residents, ensuring equal funding opportunities.
7. **Digital Platform for Funding Calls and Opportunities:** Develop a digital platform to facilitate access to information on funding calls, financing, and opportunities for projects in favelas.
8. **Training in Project Development and Financial Management:** Create training programs for community leaders and cultural entrepreneurs in favelas, helping them develop projects and manage resources efficiently.
9. **Partnerships with Cultural Spaces:** Establish partnerships between museums, theaters, and other cultural institutions with schools and organizations in favelas, promoting visits and educational programs that engage with local culture.
10. **Digitization and Preservation of Cultural Heritage:** Implement programs to digitize and preserve the cultural heritage of favelas, including oral histories, traditions, and artistic expressions.



11. **International Cultural Exchange Network:** Create a cultural exchange network between favelas and peripheral communities in different G20 countries, promoting the exchange of experiences and knowledge.
12. **International Scholarships:** Establish a scholarship program for talented young people from favelas in technology and creative fields, encouraging skill development.
13. **Global Awareness Campaign:** Develop a global campaign to highlight the cultural richness and innovative potential of favelas, combating stereotypes and promoting a positive image of these communities.
14. **Digital and Cultural Inclusion Index:** Create an index to measure digital and cultural inclusion in favelas, with clear metrics and annual monitoring by G20 countries to assess progress and identify areas for improvement.
15. **Digital Literacy Training:** Implement digital literacy training programs, especially for the elderly, to ensure everyone can use technology effectively and safely.
16. **Regulation of Harmful Advertising and Content:** Develop and implement strict regulations to control harmful advertising and the spread of fake news on digital apps and platforms.
17. **Digital Security Education:** Include digital security education in school curricula and community programs, teaching users to identify and avoid fake news and protect their personal data.
18. **Data Privacy Protection:** Establish robust data protection policies that guarantee user privacy and limit the mining of personal data for commercial purposes. Encourage transparency from companies on how user data is collected and used.

TASK FORCE 6

SUSTAINABLE FINANCE

1. CURRENT SCENARIO

Given the substantial challenges favelas face in achieving sustainable finance, it is crucial to acknowledge the innovative role of Brazil's G20 presidency in placing inequality at the center of the discussion. This initiative reflects Brazil's commitment to promoting an inclusive agenda that directly addresses the obstacles faced by vulnerable populations, especially with regard to financial exclusion and lack of access to essential services for economic, social, and environmental development.

Financial exclusion is one of the biggest barriers to investment opportunities and economic growth in favelas, as many residents lack access to credit and banking services. Additionally, the lack of access to financial education hampers efficient resource management by residents, making planning and investment difficult. Financial education programs are crucial to fostering a culture of savings and effective financial management. Another obstacle is poor infrastructure, such as the absence of sanitation, electricity, and internet, which hinders the implementation of sustainable projects and limits access to digital and economic opportunities.

Social inequality and violence further aggravate these challenges, perpetuating cycles of poverty and excluding favelas from sustainable economic development. Insecurity deters investments and hinders long-term projects. Overcoming these obstacles requires collaboration between the government, private sector, and civil society through inclusive policies, strengthening local cooperatives and microcredit, and respecting the unique characteristics of each community.

In this process, both multilateral development banks (MDBs) and national development banks play fundamental roles. These institutions have the potential to finance infrastructure projects, providing the resources needed to improve areas such as sanitation, renewable energy, transportation, and digital connectivity, which are essential pillars for the sustainable development of favelas and peripheral communities. The coordinated support of these entities is crucial to ensure that peripheral communities are robustly and sustainably integrated into economic development.



At Favela 20, we welcome the initiatives launched by the Brazilian presidency within the G20 task forces, such as the Global Alliance Against Hunger and Poverty, the Global Mobilization Against Climate Change, and the International Taxation Agenda. These initiatives are essential to mobilizing resources, improving global governance, and promoting public policies, all aimed at combating hunger, poverty, inequalities, and the climate emergency. For favelas, the inclusion of these agendas represents an opportunity to be part of global sustainable development projects, which can

2. **Create Social Impact Funds:** Establish funds to finance sustainable projects in favelas, in line with the Global Alliance Against Hunger and Poverty policy basket, focusing on housing, education, and entrepreneurship.
3. **Include Favelas in Urban Planning:** Recognize favelas as drivers of growth and integrate them into city development, aligning with the G20 inequality agenda.
4. **Expand Access to Microcredit:** Broaden microfinancing for small and medium entrepreneurs in favelas, with support from local cooperatives and initiatives from MDBs and national development banks.
5. **Encourage Financial Cooperatives:** Promote the formation of community credit cooperatives, which operate based on solidarity and can provide financial solutions tailored to local needs.
6. **Promote Digital Inclusion:** Invest in digital infrastructure and provide financial training for residents so they can access financial services and improve their resource management.
7. **Encourage Partnerships:** Stimulate collaborations between governments, companies, and civil society to develop sustainable financial solutions tailored to peripheral communities.
8. **Facilitate Access to Banking Services:** Reduce barriers to accessing bank accounts and formal financial services to ensure residents can participate in the formal economy.

- 9. Develop Inclusive Fintech Solutions:** Encourage the development of fintechs that address favela needs, such as digital payments, micro-investments, and accessible transfers.
- 10. Support Community Entrepreneurship Initiatives:** Promote entrepreneurship programs and local training that empower residents to create sustainable economic solutions.
- 11. Promote Financial Inclusion for Women and Youth:** Prioritize initiatives that support women and youth in favelas, ensuring they have access to financial resources and economic growth opportunities.
- 12. Increase Transparency and Financial Governance:** Develop systems that ensure transparency in financial flows and promote responsible governance in microfinance initiatives and cooperatives in peripheral areas.
- 13. Support the Transition to a Green Economy:** Invest in sustainable projects in renewable energy and the circular economy in favelas, encouraging green and sustainable finance practices in these regions.


